## Despite directions, Delhi private schools didn't give admission to EWS children: NCPCR

**NEW DELHI, AUG 19 / -** The National Commission for Protection of Child Rights (NCPCR) on Friday said despite its directions, private schools in Delhi did not give admission to certain children under the economically weaker section (EWS) category.

In a letter to the Delhi chief secretary, the NCPCR sought details of EWS admissions in private schools since the 2020-21 academic year. It has been observed that despite strict

directions to the officers and branches involved in ensuring admission of the candidates under EWS/DG and CWSN category, they have not been given admission till date.

"Subsequently, you are requested to provide details of the following for academic years 2020-21, 2021-22 and 2022-23: Year-wise vacancy for EWS/DG category candidates, seats allotted against the vacancy, and total number of children admitted against the seats allotted in private schools of Delhi," it said. The commission also asked how many seats remained vacant in the respective year after admission of children against allotted seats.

## Some convicts in Bilkis Bano case 'Brahmins with good sanskaar', says Gujarat BJP MLA

**AHMEDABAD, AUG 19 / -** Some convicts in the Bilkis Bano case of the 2002 Gujarat riots are "Brahmins with good sanskaar (values) and may have been 'fixed' for their family activities, a BJP MLA, who was in the state government panel that recommended remission to all the 11 men found guilty, has said.

However, a day after making the claim on camera to news portal Mojo Story, Godhra MLA C K Raulji said he believes that rapists do not have any caste and those guilty should be punished. "Rapists do not belong to any caste, and I have not said anything like that. My statement is being shown in a wrong way.

If someone is guilty he should get punishment for it. We should respect court's verdict," Raulji tweeted on Friday.

His tweet came a day after his statement on the caste of some of the convicts of Bilkis Bano case created controversy. Raulji on Thursday said he does not know whether the convicts, released after spending more than 15 years in jail, were involved in the crime. On August 15, all the 11 convicts sentenced to life imprisonment in the 2002 case of Bilkis Bano's gang rape and murder of her seven family members during the communal riots walked out of the Godhra sub-jail after the BJP government in Gujarat allowed their release under its remission policy. "We took the decision on the

basis of a Supreme Court order.

We were asked to look at their (convicts') behaviour and decide (on their early release)," Raulji, who was one of the members of the government-appointed committee that recommended granting of remission to the convicts, told Mojo Story news portal.

"We asked the jailer and learnt that their behaviour was good in the prison...also (some of the convicts) are Brahmins. They have good 'sanskaar' (values)," said the ruling party legislator. The Gujarat government's decision has invited sharp criticism from the opposition parties who have said the move was against the Centre's guidelines.

However, Raulji said the convicts may have been fixed. "It is possible that they (the convicts) might have been fixed in the case due to their past family activities. When such riots take place, it happens that those who are not involved

after their release from prison, he said they had not welcomed them. The Gujarat government released the 11 convicts after the Supreme Court directed it to consider their plea for relief under the state's 1992 remission policy.

A special CBI court in Mumbai had on January 21, 2008, sentenced to life imprisonment all the 11 accused in the case for murder of seven family members of Bilkis Bano, a riots survivor, and her gang rape.

Their conviction was later upheld by Bombay High Court. These convicts served more than 15 years in prison after which one of them approached the Supreme Court with a plea for his premature release. (PTI)

## Over 5K residents, 2,500 vehicles to be moved out on Noida twin towers demolition day

**NOIDA, AUG 19 / -** More than 5,000 residents will vacate Emerald Court and ATS Village societies and over 2,500 vehicles will be removed from there on August 28 - the day of demolition for Supertech's illegal twin towers in Noida, officials said.

While the twin towers had come up on premises of Emerald Court only, ATS Village is adjoining the illegal structures on the other side in Sector 93A of the city. The impact of the demolition of the nearly 100 metre tall twin towers would be maximum on these two societies and its residents, the officials said.

In pursuance of a Supreme Court order that found the twin towers illegal, they are scheduled to be demolished at 2.30 pm on August 28 by controlled implosion technique. Over 3,500 kg of explosives will be used to raze them, according to officials of the demolition firm Edifice Engineering. According to the evacuation plan, finalised on Thursday, the residents of Emerald Court and ATS Village will have to vacate

650 flats in Emerald Court and 450 flats in ATS Village. Both societies have a combined number of residents over 5,000 who will be required to move out as per schedule on August 28," a Noida Authority official said. "As for the removal of vehicles, several residents have more than one vehicle. There are around 1,200 vehicles in Emerald Court and 1,500 vehicles in ATS Village that will have to be moved outside. The Noida Authority will provide space for them in the multilevel parking facility at Botanical Garden metro station," the official said.

The multi-level parking at Botanical Garden Metro station can easily accommodate more than 5,000 vehicles at a time, according to the official. Entry of people, vehicles and animals will be restricted in the close proximity area -- known as exclusion zone -- of the twin towers in Sector 93A, the plan stated. The Noida-Greater Noida Expressway, which is close to the twin towers, will remain shut for
