Pursuant to Regulation 30 read with schedule III of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations 2015, and SEBI circular no. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024, we wish to inform you that **Trishakti Industries Limited** has recently undertaken a significant deployment of heavy lifting equipment for a **renewable energy project of Reliance Industries Limited**.

To support this deployment, the Company has completed a fresh capital expenditure of approximately **₹19 crores in a single tranche**, towards the purchase of **Hydraulic truck-mounted cranes**.

This marks the **largest single capital outlay** by the Company for a single project and is a part of our continued strategy to strengthen our presence in the infrastructure equipment hiring segment.

With this, the **cumulative capital expenditure for FY26** has reached approximately **₹25 crores**, and is expected to contribute meaningful revenue and profitability in the upcoming quarters.



